## LICENCE CONDITIONS

The granting of this licence is subject to the following conditions:

- 1) Hollywood Sportsbook Mpumalanga (Pty) Ltd must have legal possession of all premises specified in this licence, including the URL. Furthermore, all online and land-based facilities must be kept safe, secure and in good working order.
- 2) Hollywood Sportsbook Mpumalanga (Pty) Ltd shall provide to the Mpumalanga Economic Regulator guarantees as determined by the Mpumalanga Economic Regulator from time to time, for liabilities of Hollywood Sportsbook Mpumalanga (Pty) Ltd in relation to: betting levies payable, and betting debt payable by Hollywood Sportsbook Mpumalanga (Pty) Ltd. The guarantees shall be maintained at such levels as may be determined by the Mpumalanga Economic Regulator from time to time.
- 3) Hollywood Sportsbook Mpumalanga (Pty) Ltd shall submit to the Mpumalanga Economic Regulator periodically as stipulated by the Mpumalanga Economic Regulator from time to time, a deliverable report containing all information required in the format approved by the Mpumalanga Economic Regulator.
- 4) Hollywood Sportsbook Mpumalanga (Pty) Ltd shall establish and maintain a Compliance Plan and Compliance Committee. All measures as per the aforementioned compliance plan must be implemented and adhered to, in order to ensure that the licensee does not bring the gambling industry into disrepute. The Compliance Committee must meet at such intervals and submit minutes of its meetings to the Board, as approved by the Mpumalanga Economic Regulator from time to time.
- 5) Hollywood Sportsbook Mpumalanga (Pty) Ltd shall ensure that internal control procedures of the company are submitted to the Mpumalanga Economic Regulator prior to commencement of operations and are adhered to.

- 6) Hollywood Sportsbook Mpumalanga (Pty) Ltd shall on a continuous basis, satisfy the Mpumalanga Economic Regulator (MER) of sufficient measures taken to ensure that no persons under the age of 18 years have access to any online and land-based betting facilities authorised in terms of this licence.
- 7) Hollywood Sportsbook Mpumalanga (Pty) Ltd shall have an electronic record keeping system certified in terms of applicable South African National Standards (SANS) and approved by the Mpumalanga Economic Regulator, with access to the system provided and maintained for the Mpumalanga Economic Regulator at the cost of Hollywood Sportsbook Mpumalanga (Pty) Ltd.
- 8) Hollywood Sportsbook Mpumalanga (Pty) Ltd Ltd must ensure that they have legal rights to conduct betting activities on sporting events or other contingencies, where applicable. Furthermore, all contingencies offered on online and land-based betting facilities authorised in terms of this licence must be approved by the MER.
- 9) All wagering or betting equipment, software, online links or feeds and data warehousing must be supplied and maintained by holders of certificates of suitability or licensed manufactures, suppliers, and distributors, unless a bookmaker uses and maintain its own systems.
- 10) The approved URL must have a visible link on the landing page to a copy of this licence certificate, as approved by the MER from time to time.
